The following is a list of major activities during the reporting period:

- Converted the LFRD Movable Bridge Specification to a dual unit format.
- Received, reviewed and organized 65 agenda items for the '05 SCOBS meeting.
  While the original submissions of agenda items are getting closer to the editorial
  standards each year, most still require some processing, especially now that
  AASHTO staff is preparing the Interims. There were a few agenda items that
  had to be reviewed technically with the appropriate Technical Committee Chair.
  The rewrite of Section 10 required extensive telephone discussions.
- Attended Technical Committee and other meetings as approved.
- Worked on finalizing Item 30 from the '04 SCOBS meeting. This is the item which was approved subject to rewriting by M and M and approval by T-10.

There are two excerpts from previous correspondence which help to put costs associated with our Year 2 activities in proper perspective.

From an emailed progress report of 8/04, "In an Email following the Oversight Panel meeting in June we suggested to Ms. Ried that we keep billing to the budget for our first year, which originally covered work until the end of June, 2004. We made this suggestion because our scope had changed so much now that AASHTO was going to prepare the LRFD Interims, do the final editing of the construction specification, and all conversion and editing of the movable specification. No exception to this was taken." This reduced to costs charged to our second year budget by the amounts indicated for JN 2200 and JN2202 below.

The following revised broad budget was established for the second year and submitted in February, 2005.
